Are there any special features that give the park local distinctiveness?	There is a natural habitat area with wildflower meadow on the site, with mown paths through the long grass

Is the space clean and free from litter and dog fouling?	The park is serviced 3 times a week which includes litter picking and bin emptying. Due to the area being very popular with dog walkers, there is an issue with dog fouling despite the provision of waste bins
Is the site well-maintained?	Yes
Is the planting well-maintained?	There is no formal planting on the site, but hedges, shrubs and trees are maintained on a yearly cycle

Are grassed areas well-maintained?	The grass is cut on site every 3-4 weeks, with the inside of the play cut every 2 weeks

The council has worked in partnership with Urban Buzz Cornwall on creating a pollinator-friendly wild meadow on the lower wild area of the site, planting of hundreds of bulbs and plug plants such as primrose, and is maintained as a meadow with 1 cut at the end of the summer

# **Management Plan**

**Site Name:** The Meadows Open Space

Location: The Meadows Open Space is located at the end of Boscoppa Road,

adjoining Bishop Bronescombe Primary School

**Council Ward**: Bethel

**Site Area**: 2.57 Ha (6.34 Acres)

Management: The site is owned and managed by St Austell Town Council



# **Site Features:**

The site comprises of 1 equipped play area with mixed-age group equipment, 1 Multi-Use Games Area (MUGA), a half-pipe skateboard ramp, a landscaped BMX track, nature/dog walking area, wildflower meadow, and an open grassed area.

The park has a cycle path running along the north-western boundary and is home to a number of young trees of varying species.



# **Current Management**

#### Safe and secure

The site is bordered by mature hedging and stone walling to the northern and western boundary and hedging and fencing along the boundaries with residential properties.

There is vehicle and gated-pedestrian access to the site from Boscoppa Road to the north, 2 entrance points from the cycle path along the north-eastern and south-eastern boundaries, and 2 access points from the Retallick Meadows estate to the south-west.

Currently, the park does not benefit from any internal lighting.

# Welcome

The park has general 'welcome' signage at the entrances containing information about the park.

There is signage on each of the play area entrance gates, informing park users of ownership, number to call to report damage or defects, and that no dogs are allowed inside these areas.

The park benefits from car parking spaces at the entrance to the site.

#### Clean and well-maintained

The grounds maintenance team empty the bins and litter pick on the site 3 times a week.

Sharps/drug paraphernalia discoveries are safely disposed of by council staff and reported to the relevant authorities to be recorded.

There are currently 3 litter bins and one dog bin on the park.

The grass is mown every 3 weeks in the main area during the spring/summer season to maintain a well-kept appearance and any arisings are left on site. The wildflower meadow areas are cut yearly, between October and March, and all cuttings are removed.

Tree Safety Surveys are carried out on an annual basis by an approved arboriculture contractor, to identify any works which may be needed to maintain a safe and healthy tree stock. Tree works are carried out by the Town Council's grounds team.

Recorded routine visual inspections on the play equipment are carried out weekly by the Operations Manager, with a comprehensive recorded 'operational' inspection done quarterly. This is backed up by an annual independent inspection carried out by RoSPA inspectors.

# **Health and Well-being**

The Multi-Use Games Area and Skate Ramp is used by local teenagers for informal ball games and wheeled-sports.

The equipped play area provides exercise and play opportunities to children aged 4-11-years old. Generally, the site provides a good space for leisure, recreation, and exercise for the local community.

# **Community involvement**

It is hoped that the wildflower planting initiative with Cornwall Buzz will create community interest and involvement on the site.

# Wildlife and biodiversity

Habitat and species surveys have not been carried out on the park. Vegetation works will be carried out in order to enhance the nature conservation interest of the site by creating wild areas and habitats for varying species. This will be in partnership with the Cornwall Buzz Project.

#### **Trees**

There are groups of trees of varying age and species on the site.

# Staff skills and knowledge

Skills required to manage The Meadows Open Space currently include basic horticultural maintenance such as mowing and strimming machinery, meadow management and certified chainsaw operation.

#### Sustainable approach

The area to the south east of the site is managed as a wild 'meadow' area, with paths mown through to allow visitors to walk their dogs away from the more formal play and ball games areas. No pesticides are used on this site.

#### **Finance**

Maintenance costs are met from the Parks and Open Spaces budget for all sites.

# Access gates

There is one locked vehicle access gate.

# Horticultural management

Horticulture management on this site involves tree management, mature shrub pruning and grass cutting. There is no formal planting, as the area maintains a 'natural' feel.

#### Play equipment

A new play area was installed during the winter of 2017 and included an accessible basket swing. The park is subject to a routine weekly inspection by the Operations Manager. A quarterly Operational Inspection is also undertaken, along with an independent RoSPA annual inspection.

#### **Arboriculture management**

Arboriculture works at The Meadows are carried out by the council's grounds maintenance team. An annual Tree Safety inspection is undertaken by an approved contractor to help the council maintain a safe and healthy tree stock.

#### **Future Management**

#### Safe and secure

All gates in the play area are self-closing to ensure safety and are regularly checked to ensure they are in the correct working condition.

Coppicing of dense trees and shrubs around northern boundary to improve visibility and sight-lines.

The recent implementation of an annual tree survey and associated works will enhance the tree stock whilst also ensuring the trees are as safe as possible. Possible addition of kissing-gates and bollards to prevent unauthorised vehicle access

#### Welcome

Signage to this site needs improvement. The signs on entrances and the play area gates are adequate, but signs that clearly state where the park is could be added to encourage more people to use the park.

#### Clean and well-maintained

Current arrangements to be kept under review.

# **Health and well-being**

The MUGA, green space and play areas provide an important opportunity for exercise, especially for young people. Usage of the BMX track should be promoted as it is a real asset on the site.

Signs highlighting the cycle path need to be reinstated/added to encourage more use.

# **Community involvement**

Going forward, the formation of a Friends of The Meadows group would be beneficial to the future management of the park. The wildflower meadow and nature areas would benefit from increased community involvement in future in order to be sustainably managed.

# Staff skills and knowledge

The Town Council has a recently qualified horticulture apprentice to add to the skill set of the grounds maintenance team. Further staff training in woodland and meadow management would be beneficial to the ongoing management of the park.

# **Management Plan**

**Site Name:** Sandy Hill Park

**Location:** Junction of Bethel Road and Menear Road, St Austell

**Council Ward**: Bethel

**Site Area**: 1.2 acres (0.48 hectares)

Management: The site is owned and managed by St Austell Town Council



# **Site Features:**

The site comprises of 1 equipped play area with mixed-age group equipment, a fully accessible tarmac path, 2 picnic tables, 1 recycled-materials bench and a wildflower area.

# **Current Management**

#### Safe and secure

The site is bordered by mature hedging and steel palisade fencing to the west, stone hedge along the northern boundary, and a low stone wall bordering the east and south boundary.

There is vehicle and gated-pedestrian access to the site from Menear Road to the east, and 2 gated pedestrian entrances from the south and east.

The park does not have any internal lighting.

#### Welcome

The park has general 'welcome' signage at the lower end containing information about the park.

There is signage on each of the play area entrance gates, informing park users of ownership, number to call to report damage or defects, and that no dogs are allowed inside these areas.

#### Clean and well-maintained

Waste management on this site is carried out by the Town Council.

Sharps/drug paraphernalia discoveries are safely disposed of by council staff, and reported to the relevant authorities to be recorded.

There are currently 2 litter bins on site.

The grass is mown every 3 weeks in the main area during the spring/summer season to maintain a well-kept appearance and any arisings are left on site. The wildflower meadow areas are cut once yearly, between October and March, and all cuttings are removed.

Tree Safety Surveys are carried out on an annual basis by an approved arboriculture contractor, to identify any works which may be needed to maintain a safe and healthy tree stock. Tree works are carried out by an approved arboriculture contractor.

Recorded routine visual inspections on the play equipment are carried out weekly by the Operations Manager, with a comprehensive recorded 'operational' inspection done quarterly. This is backed up by an annual independent inspection carried out by RoSPA inspectors.

# **Health and Well-being**

The recently upgraded timber play area provides 'natural' exercise and play opportunities to children aged 4-11-years old. Generally, the site provides a good space for leisure, recreation, and exercise for the local community, and has proved to be very popular with all age groups since it was refurbished.

# **Community involvement**

It is hoped that the wildflower planting initiative with Cornwall Urban Buzz during 2018 will continue to create community interest and involvement on the site.

# Wildlife and biodiversity

Habitat and species surveys have not been carried out on the park. Vegetation works will be carried out in order to enhance the nature conservation interest of the site by creating wild areas and habitats for varying species. This will be in partnership with the Cornwall Buzz Project.

#### **Trees**

There are groups of trees of varying age and species on the site.

# Staff skills and knowledge

Skills required to manage Sandy Hill Park include basic horticultural maintenance such as mowing and strimming machinery, meadow management and certified chainsaw operation.

# Sustainable approach

The area inside the fenced-off section, and the small wildflower meadow adjacent, are managed sustainably by carrying out one cut per year and removing the cuttings. No pesticides are used on this site.

#### **Finance**

Maintenance costs are met from the Parks and Open Spaces budget for all sites.

#### Access gates

There is one locked vehicle access gate.

# Horticultural management

Horticulture management on this site involves tree management and grass cutting. There is no formal planting, so the area maintains a 'natural' feel.

# Play equipment

A new play area was installed during 2018. The park is subject to a routine weekly inspection by the Operations Manager. A quarterly Operational Inspection is also undertaken, along with an independent RoSPA annual inspection.

# **Arboriculture management**

Arboriculture works at Sandy Hill are carried out by the Council's grounds maintenance team. An annual Tree Safety inspection is undertaken by an approved contractor to help the council maintain a safe and healthy tree stock.

#### <u>Future Management</u>

#### Safe and secure

All gates in the play area are self-closing to ensure safety and are regularly checked to ensure they are in the correct working condition.

The recent implementation of an annual tree survey and associated works will enhance the tree stock whilst also ensuring the trees are as safe as possible.

#### Welcome

Due to the low boundary walls providing excellent visibility and the recent refurbishment using attractive timber for the equipment, the park provides a welcoming feel to all who visit.

#### Clean and well-maintained

The current waste management arrangements will be kept under review.

#### Health and well-being

The new play area was designed to utilise the natural contours of the site, and most of the play equipment is net and climbing-based. This encourages very active play amongst children that use it.

# **Community involvement**

Up until the refurbishment of the park, there was an active Friends of Sandy Hill Park group. Upon completion of the refurbishment however, the group decided to disband. Money from the groups past fund-raising efforts was transferred to the Town Council to spend on the park, and a new bench made from recycled materials was purchased and installed in 2019.

# Staff skills and knowledge

The Town Council has a recently-qualified horticulture apprentice to add to the skill set of the grounds maintenance team. Further staff training in woodland and meadow management would be beneficial to the ongoing management of the park.

# **Future Action Points**

Further seating and the addition of more seating would be beneficial, as the park can get very busy at peak times such as summer holidays.

# Site description:



Management: The site is owned by St Austell Town Council and managed by

the Town Council's grounds maintenance staff.



#### **Site Features**

The site contains 1 mixed age-group play area, adult fitness equipment, a Multi-Use Games Area, a large open green space and a bandstand. This park is bordered on all sides by a number of large, mature trees of varying species, and is located within a Conservation Area.

# **Topography**

From a sloped embankment to the east adjoining Park Road, the site slopes gently west towards Bridge Road.

# **Drainage and flooding**

Due to the park being located below the surrounding ground level, the ground does not drain easily and can become saturated, although no severe flooding occurs.

#### **Services**

There are no services on the site.

# **Current management**

#### Safe and secure

There is secure boundary fencing along the southern boundary with Parkhouse Flats, ornamental railing fencing with gated access at the eastern boundary with Park Road, a large retaining wall with gated access along the northern boundary with Truro Road, and gated access from Bridge Road. There are also self-closing gates at each of the entrances to the play area.

Currently, the park does not benefit from internal lighting, but there is CCTV on Truro Road which partially covers the park, and also a camera overlooking the park on the roof of the adjoining block of flats.

#### Welcome

The park currently has no general 'welcome' signage at the entrances, although there is signage on each of the play area entrance gates, informing park users of ownership, number to call to report damage or defects, and that no dogs are allowed inside these areas.

#### Clean and well-maintained

The volume of litter on site can be substantial. The grounds maintenance team litter pick and empty the bins on the site 3 times a week. Discarded sharps such as needles are routinely found here and disposed of in a safe and correct manner by the Council's grounds maintenance team, and reported to the relevant authorities to be recorded.

There are currently 4 mixed-use bins on site.

The grass is mown 2-3 weekly to maintain a tidy appearance, and shrubberies are maintained as and when needed. There are no bedding flowers on site due to previous problems with vandalism.

The large embankment area around the bandstand was planted with flowering shrubs and bulbs during 2018.

The trees are safety-inspected on an annual basis to identify any works which may be needed to maintain a healthy tree stock.

Recorded routine visual inspections on the play equipment are carried out weekly by the Operations Manager, with a comprehensive recorded operational inspection done quarterly. This is backed up by an annual independent inspection carried out by RoSPA inspectors.

# **Health and Well-being**

The Multi-Use Games Area is used by local teenagers for informal ball games and The equipped play areas and green space provide exercise and play opportunities for younger children. The entire layout of the site provides space for leisure, recreation, and exercise for the whole community.

# **Community involvement**

The recently-formed Friends of Truro Road Park' group has provided an opportunity for greater community involvement and partnership working in future. Community Days organised by the Cornwall Councillor for Gover are held on the park annually.

# **Service delivery**

Landscape maintenance is carried out by St Austell Town Council's Grounds Maintenance staff.

Structural, arboriculture and play equipment maintenance is carried out by approved contractors on behalf of the town council as and when required.

# Staff skills and knowledge

Skills required to manage Truro Road Park currently include basic horticultural maintenance such as mowing and strimming machinery, and shrub maintenance. Long-term, it would be beneficial for the grounds maintenance team to obtain arboricultural skills to inspect and maintain the trees 'in-house'. Training staff in play equipment inspection is also needed.

#### **Trees**

There are 28 trees of varying species on the park, ranging in age from very young to veteran.

# **Arboriculture management**

Arboriculture works are carried out by either the town council's grounds maintenance team or an approved contractor, depending on the nature of the works required. An annual Tree Safety Survey is conducted in order to help the council manage its tree stock safely and sustainably.

As the park is within a Conservation Area, any works to trees require St Austell Town Council to gain permission from Cornwall Council before being undertaken.

#### **Sustainability**

The site is managed with only sporadic use of pesticides (once or twice per year). The weeds are occasionally controlled with the use of Glyphosate on the hard surfaces. Mulch from trees works carried out by town council staff is reused on flower beds where possible.

#### **Finance**

Maintenance costs are met from the Parks and Open Spaces budget for all sites. An unregistered charity exists for the management of this site.

# Horticultural management

All horticultural management adheres to the standards set in the council's Service Delivery Standards, and the council aim to improve these standards year on year.

#### Play equipment

The park is inspected weekly by the Operations Manager due to the large amount of play equipment on the site. There is also an ongoing issue with anti-

social behaviour at the park. All sites are subject to in-depth Operational Inspections by the Operations Manager every 3 months, and an independent RoSPA inspection annually. All inspections (routine, operational and annual) are recorded and kept on file.

# **Access gates**

There is one locked access gate, which the town council hold keys to.

# **Future Management**

#### Safe and secure

A large sycamore tree is regularly tested and monitored as it is deemed to be nearing the end of life.

Ongoing basic maintenance of play equipment, gates and furniture will keep the park to a good standard.

#### Welcome

Signage both to, and at, this site needs improvement. The signs on the play area gates are adequate, but vibrant and interesting entrance signs that clearly state what the park has to offer need to be added.

#### Clean and well-maintained

Continued enhancement of horticulture in the park is planned, with the addition of further flowering shrubs on the embankment and spring bulbs.

# Sustainable approach

Maintain minimal use of pesticides on the site. Use of compostable materials such as mulch on flower beds. Addition of recycled-plastic seating when replacing old timber benches.

#### Health and well-being

The MUGA, green space, fitness equipment and play area provide an important opportunity for exercise, especially for young people. If the MUGA is not being used to its full potential, wider use could be encouraged through working with local youth groups and fitness organisations.

# **Community involvement**

The Town Council have worked with the Probation Service, who carried out maintenance works on the park during 2017. However, there is capacity for increased community involvement. Better links could be established with local community groups and sports organisations and it is hoped the formation of the Friends of Truro Road Park group will contribute to this.

# Staff skills and knowledge

The Town Council has a skilled horticultural team and is in the process of recruiting two apprentices.

# Issues that need to be addressed in future

- . Regular discarding of used needles within the park
- . Dog fouling
- . Vandalism
- . Increasing community use of the park



# **Site Features:**

The site comprises of 1 equipped play area with mixed-age group equipment, a fully accessible tarmac path, 2 picnic tables, 1 bench. There is an informal joint use agreement with Mount Charles school for the use of the playing field.

# **Current Management**

#### Safe and secure

The site is bordered by mature hedging and metal fencing, with a Cornish stone hedge along the south boundary.

There is vehicle and gated-pedestrian access to the site from Woodland Road and 2 gated pedestrian entrances from the public footpath from the north.

The park does not have any internal lighting.

# Welcome

There is signage on each of the play area entrance gates, informing park users of ownership, number to call to report damage or defects, and that no dogs are allowed inside these areas.

# Clean and well-maintained

The Town Council assumed responsibility for bin emptying and litter picking on the site from  $1^{st}$  April 2020.

Dogs are banned from this park under the Cornwall Council Public Space Protection Order 2020 (control of dogs).

There are currently 2 mixed-use litter bins on site.

The grass is mown every 2 weeks in the main area during the spring/summer season to maintain a well-kept appearance and ensure that the school have a satisfactory surface to use for games/PE.

Tree Safety Surveys are carried out on an annual basis by an approved arboriculture contractor, to identify any works which may be needed to maintain a safe and healthy tree stock. Tree works are also carried out by an approved arboriculture contractor.

Recorded routine visual inspections on the play equipment are carried out weekly by the Operations Manager, with a comprehensive recorded 'operational' inspection done quarterly. This is backed up by an annual independent inspection carried out by RoSPA inspectors.

# **Health and Well-being**

The recently upgraded timber play area provides 'natural' exercise and play opportunities to children aged 4-11-years old. Generally, the site provides a good space for leisure, recreation, and exercise for the local community, and has proved to be very popular with all age groups since it was refurbished.

# Wildlife and biodiversity

There is zero pesticide use in the maintenance of Woodland Road Park.

# **Trees**

There are groups of trees of varying age and species on the site.

# Staff skills and knowledge

Skills required to manage Woodland Road Park include basic horticultural maintenance such as mowing and strimming machinery.

#### **Finance**

Maintenance costs are met from the Parks and Open Spaces budget for all sites.

#### **Access gates**

There is one locked vehicle access gate.

#### Horticultural management

Horticulture management on this site involves tree management and grass cutting. There is no formal planting.

### Play equipment

A new play area was installed during 2018. The park is subject to a routine weekly inspection by the Operations Manager. A quarterly Operational Inspection is also undertaken, along with an independent RoSPA annual inspection.

# **Arboriculture management**

Arboriculture works are carried out by an approved contractor. An annual Tree Safety inspection is undertaken by an approved contractor to help the council maintain a safe and healthy tree stock.

### **Future Management**

#### Safe and secure

All gates in the play area are self-closing to ensure safety and are regularly checked to ensure they are in the correct working condition.

The recent implementation of an annual tree survey and associated works will enhance the tree stock whilst also ensuring the trees are as safe as possible.

#### Welcome

Due to the low boundary walls providing excellent visibility and the recent refurbishment using attractive timber for the equipment, the park provides a welcoming feel to all who visit.

#### Clean and well-maintained

The Council will keep the current arrangements under review.

# **Health and well-being**

Most of the play equipment is net and climbing-based. This encourages very active play amongst children that use it.

# **Staff skills and knowledge**

The Town Council has a recently-qualified horticulture apprentice to add to the skill set of the grounds maintenance team.

#### **Future Action Points**

There is a need to formalise the joint use agreement with Mount Charles School and explore further tree planting opportunities,

# Site description

**Location:** Poltair Park is bordered to the north by Trevarthian Road, and to

the south by Carlyon Road. **Council Ward:** Poltair

**Site Area:** 2.01Ha (4.97 acres)

Management: The site is owned by St Austell Town Council, and maintained by

the Town Council's grounds maintenance staff

#### **Site Features**

The site comprises of 1 fully-equipped junior play area, 1 fully-equipped toddlers play area, 1 fenced skate park, 1 fenced Multi-Use Games Area (MUGA), an open, grassed recreation area, a Bowling Club and adjoining car park for use by the bowling club only. There is a café with an accessible toilet operated during the spring/summer months.

The park is intersected by footpaths lined with mature trees and is a popular cut through for local residents and students at the nearby Poltair School and Cornwall Council.



### **Topography**

The park slopes from Trevarthian Road to the north, gradually south down to Carlyon Road.

#### **Drainage and flooding issues**

Overall, drainage on Poltair Park is poor. From the north entrance by St Austell Bowling Club, rainwater runs down to the flat grassed 'roundabout' by the cafe and occasionally causes pooling. A bridge and drainage have been installed at the roundabout to allow pedestrians to cross and avoid any water logged areas.

#### Safe and secure

There is secure boundary fencing and Cornish hedging with mature trees and shrubs to all sides, with 1 entrance from Trevarthian Road to the north (includes vehicle access to Bowling Club car park), and 2 pedestrian access points (one with traffic barrier) from Carlyon Road to the south.

The installation of the new café included some internal lighting on the section of path alongside the skateboard park. A CCTV camera was also installed which covers the southside of the park. An internal CCTV camera is also located in the café.

#### Welcome

The park currently has no general 'welcome' signage at the entrances. Once the proposed kiosk/toilets project has been completed, signage with a site map at each of the entrances is planned.

There is signage on each of the play area entrance gates, informing park users of ownership, the number to call to report damage or defects, and that no dogs are allowed inside these areas.

#### Clean and well-maintained

As this park is the most popular and well-used in the town, the volume of litter can be substantial. The grounds maintenance team litter pick and empty the bins on the site 3 times per week, but also litter pick before mowing the grass on the site.

Any sharps/drugs paraphernalia discoveries are disposed of safely by council staff and reported to the relevant authorities to be recorded.

The grass is mown fortnightly during the summer months to maintain an almost formal appearance, and the flower beds and shrubberies are maintained on the same cycle as the grass cutting.

The flower beds are planted with seasonal bedding flowers to add to the perennial planting already in place in the beds.

The trees are safety-inspected on an annual basis to identify any works which may be needed to maintain a safe and healthy tree stock.

Recorded routine visual inspections on the play equipment are carried out weekly by the Operations Manager, with a comprehensive recorded 'operational' inspection done quarterly. This is backed up by an annual independent inspection carried out by RoSPA inspectors. A report is then produced of the inspector's findings, and any repairs and maintenance are carried out in accordance with the recommendations in the report.

#### **Health and Well-being**

The Multi-Use Games Area and the Skate Park are well-used by local children and adults alike and the well-equipped play areas provide excellent exercise and play opportunities to younger children.

## **Community involvement**

A local nursery organises a fun day on the park once a year, and the bowls club on site is very popular with the local community. The town council also work with the Rotary Club to plant bulbs in the park every November. Ad hoc fitness groups use the park throughout the year.

#### Staff skills and knowledge

Skills required to manage Poltair Park include basic horticultural maintenance such as mowing and strimming machinery, and shrub maintenance. Long-term, it would be beneficial for the grounds maintenance team to obtain arboriculture skills to inspect and maintain the trees 'in-house'.

#### **Sustainability**

The site is generally managed with only sporadic use of pesticides (Glyphosate) to treat the weeds on the hard surfaces. The Town Council continually monitor the market for non-chemical alternatives to weed control and hope to eventually achieve zero-use of pesticides on its parks and open spaces.

Mulch from trees works carried out by Town Council staff is re-used on flower beds where possible.

#### **Finance**

Maintenance costs are met from the Town Council's Parks and Open Spaces budget for all sites. Part of the park is subject to a charity which is registered with the Charity Commission. There is no funding from this source.

# Horticultural management

All horticultural management is carried out by the Town Council's grounds staff, who have many years' experience in amenity horticulture. This work adheres to the high standards set in the council's Service Delivery Standards, and the council aim to improve these year on year.



#### Play equipment

Poltair Park is routinely inspected weekly by the Operations Manager who is RPII-registered to carry out inspections of children's playgrounds. All sites are subject to in-depth Operational Inspections by the Operations Manager every 3 months, and an independent RoSPA inspection annually. All inspections (routine, operational and annual) are recorded and kept on file.

#### **Trees and Arboriculture management**

There are 33 trees within the boundary of the park, of varying size and species.

Arboriculture works are carried out by either the Town Council's grounds maintenance team or an approved contractor, depending on the nature of the works required. An annual Tree Safety Survey is conducted in order to help the council manage its tree stock safely and sustainably.

#### Access

There is only one vehicle access gate, which both the town council and bowls club hold keys to.

#### **Future Management**

#### Safe and secure

The addition of lighting within the park has improved safety for anybody passing through the park at night.

Demolition of the old toilet block should be a priority, as the area attracts litter and anti-social behaviour, as well as being a blot on the landscape.

#### Welcome

Signage needs improvement. The signs on the play area gates are adequate and compliant, but vibrant and interesting entrance signs that clearly state what the park has to offer should be added in due course.

#### Clean and well-maintained

Further enhancement of the horticulture within the park is required in order to maintain and improve upon the 4\* Pride in Parks South West in Bloom award. Potential to install a recycled plastic picnic table in outside the skateboard park. Repairs to safety surfacing in the next 12 months is required, and a long-term play equipment replacement plan should be devised. The existing play equipment is in fairly good condition, but budgetary provisions should be made to replace it in the next 8-10 years.

#### **Health and well-being**

The MUGA (Multi-Use Games Area), Skate Park, green open space and play areas provide an important opportunity for exercise, especially for young people. If the MUGA is not being used to its full potential, wider use could be encouraged through partnerships with local youth groups, café operators, social prescribing and health and fitness organisations.

# **Community involvement**

The Town Council will hopefully continue to work with the Probation Service on future projects. There is also a very positive and proactive relationship with St Austell Bowls Club.

However, there is a need for increased community involvement at Poltair Park. Better links could be established with local community groups and sports organisations and the formation of a Friends of Poltair Park group should be explored, in order to assist with the continued improvement and management of the park.

# Staff skills and knowledge

The Town Council is recruiting horticultural apprentices. The apprentices will be given the opportunity to help shape the future of Poltair Park.

# Sustainable approach

The council will continue to maintain minimal use of pesticides on site. Switching from knapsack use to Nomix TDC will enhance this, as less chemical will be dispersed on application. Use of composted materials on flower beds where possible and recycling of plants and shrubs from other sites has also been introduced.

Further tree planting in and around the large grass area will also be looked at in due course.







The Town Council assumed responsibility for bin emptying and litter picking on the site from 1<sup>st</sup> April 2020

The grass is mown every 3-4 weeks in the main area during the spring and summer.

Tree Safety Surveys are carried out on an annual basis by an approved arboriculture contractor, to identify any works which may be needed to maintain a safe and healthy tree stock. Tree works are also carried out by an approved arboriculture contractor.

Skills required to manage the site include basic horticultural maintenance such as mowing and strimming machinery, certified chainsaw operation.

Horticulture management on this site involves tree management and grass cutting. There is no formal planting.
