# **Message from the Mayor**

Being the Mayor of my home town has been the biggest honour of my life so far.

My wife Anne and I have thoroughly enjoyed every minute of the past year. I have sought to represent our town to the best of my ability and make sure the views of local people have been listened to.

I want to say a huge thank you to my fellow Town Councillors and also to our council staff, David Pooley and Sara Gwilliams, for their hard work and support over the past year.

It has certainly been an interesting year for our town and the council. We have seen further cuts to the services provided by Cornwall Council as they continue to need to save money from their budget. This has meant the Town Council having to decide whether to allow certain services to be stopped or to take responsibility for delivering them locally.

So far we have taken on the responsibility for maintaining footpaths, spraying for weeds on roads and pavements and also for the provision of CCTV coverage in the town centre. I am sure there will be much more to come in the months and years ahead, but we have shown that even though we are still a relatively new council we have the willingness and capacity to provide services where needed.

When I became Mayor one of my aims was to see a Youth Council established to give local young people a voice and encourage younger people to engage in local politics. I am delighted that St Austell now has its first ever Youth Council and we have a group of enthusiastic young men and women who will represent the views of young people.

Planning has remained a major and at times controversial issue. The decision by Cornwall Council to refuse the application for the retail park at Coyte Farm provoked an unprecedented reaction from local residents. The issue looks as though it has not gone away and the debate continues to divide opinion in the town. However, there certainly appears to be a groundswell of opinion that clearly wants to see the

investment, jobs and retailers a development of this nature would bring.

Personally I remain very concerned that St Austell is once again falling further behind Truro, as well as other towns in Cornwall, in terms of the number and quality of retailers available to local people. There is certainly a feeling around of history repeating itself as we lose out to Truro once again.

We have also seen progress on the Town Framework and the Town Council has worked hard to make sure that the views of local residents have been made known to Cornwall Council. We can only hope that those views are taken into account when the final document is published.

The future of Cornwall Council offices and jobs in our town remains in the balance. The construction of new offices in Bodmin continues to cast a large shadow and I believe remains a threat. I know that

there is a very strong feeling among local councillors that I share, that it is vital that Cornwall Council maintains its office presence in St Austell and the level of jobs we currently enjoy. It is a situation we need to monitor closely and I am sure the Town Council will continue to fight any plans to diminish Cornwall Council's presence in the town.

I have always been very proud to be a St Austell lad. That pride has grown even stronger over the past year as I have had the unique opportunity as Mayor to experience the incredible community spirit and work carried out for the good of our community by so many people. Although we continue to face many challenges, we also have some great opportunities and with the right political representation and leadership I believe together, as a community, we can make the most of what the future has to offer.

We are now into our sixth year as a Town Council but I believe we are growing into our role and responsibilities and will continue to play a vital role in helping to provide the leadership our town needs to help make our town an even better place to live, work and raise our families.

I have done my best for the past year and I now pass on the chains of office to Cllr Derek Collins and wish him well for his year as Mayor of our Town.

# **St Austell Town Council**

St Austell Town Council was formed in June 2009 and has 20 elected Councillors (4 Councillors representing the Gover Ward, 4 Councillors representing Poltair Ward, 2 Councillors representing St Austell Bay Ward, 5 representing Bethel Ward and 5 representing Mount Charles Ward).

A list of current Councillors is included on page 15 of this report.

Town Council elections were held in May 2013 and will take place next in 2017.

Each year, the Council elects one councillor to be the Mayor who then acts as the civic leader and chairs Council meetings. The Council has a Code of Conduct and is committed to proper standards and sound corporate governance arrangements. Meetings are usually held in Cornwall Council's One Stop Shop at Penwinnick Road, St Austell. The full Council

meets approximately every six weeks. In addition to the full Council meetings, the Council has three standing committees to ensure the effective management of its business:

• Finance and General Purposes Committee

- Planning Committee
- Communities Committee

There is a public participation session at each of the Council's official meetings to allow members of the public to make comments or raise issues about items on the agenda. From time to time, working groups are formed to address particular issues.

The Town Council is very keen to ensure that however the town changes in the future the process is managed properly and that appropriate infrastructure accompanies it.

The Town Council currently manages very few services. Its main role is to represent and lobby on behalf of local residents and businesses to ensure that their views are taken into account by the larger organisations operating in the area.

It has, however, submitted a business case to Cornwall Council to demonstrate how it could provide more services within the town. Cornwall Council is currently considering this.

The Town Council is consulted on all planning and some licensing applications in its area and in relation to many of the other services provided by Cornwall Council.

The Town Council is keen to work in

partnership with Cornwall Council and other agencies in order to ensure delivery of the highest quality services and facilities to local residents.

## 2013/14 **Activities**

#### Feast Week

St Austell Town Council, along with a large number of community groups, charities, businesses and community interest groups, organised a week of feasten celebration in July 2013 in St Austell. The week, which was the first of its kind for 70 years, was a real success in the town and was recreated in the summer of 2014.

The week included historic talks, walks, a schools' concert, a furry dance, a community

play, an open air church service, a gargoyle parade and a theatrical performance. Most of the events were free for the public to attend and geared towards the entire St Austell community. The Town Council successfully obtained £10,500 of grant funding from various sources to enable this event to take place.

Scheme bid

#### **Town Heritage Scheme**

Following the successful completion of the Conservation Area Appraisal for St Austell, the Town Council is working with Cornwall Council and the Market House to bid for a Townscape Heritage (TH) scheme for St Austell. Such bids usually take up to two years to develop.

Townscape Heritage schemes fund quality traditional repairs to targeted

historic buildings in Conservation Areas. A scheme in St Austell would complement Management Plan Conservation Area Management Plan and the ongoing Business Improvement District (BID) scheme. It will economy and make the town a better place to live, work and visit.

The St Austell and surrounding parishes Town Framework will be a document which will set out a vision and options for the future development and change of the urban area of St Austell and its immediate hinterland. Work has taken place throughout the year with Cornwall

draft Town Framework consultation document. A number of consultation exercises and meetings have taken place and it is hoped that a final Town Framework will be in place within the next 12 months. Once finalised, this document will be part of Cornwall Council's formal planning policies.

#### St Austell Business Improvement District (BID)

The Business Improvement District (BID) for St Austell became operational in April 2013. This is an initiative funded by local business ratepayers in the town centre to enhance and promote the BID area. The Town Council has supported the BID in its first year of operation. It is already beginning to make significant progress and has organised a number of events and environmental initiatives in the town centre.

## **Footpaths/Weed Treatment**

Due to cutbacks at Cornwall Council, the Town Council in the summer of 2013 took on the maintenance of the designated footpaths in St Austell for the first time. Responsibility for weed treatment on public highways and pavements also passed to the Town Council in the spring of 2014.

#### Youth Council

One of the priorities for our Mayor during his Mayoral year was to set up a Youth Council for St Austell.

A small working group was set up, and the Mayor visited the local college and secondary schools to explain what was involved.

On the 28th April 2014 a Youth Council for St Austell was formally constituted and is currently working on an outdoor cinema event in the town.

#### New Town Council website

At the end of 2013 the Town Council reviewed and updated its website. The Town Council regularly updates the website which includes information such as our Councillors, Council agendas and minutes, financial information and the Town Council's Small Grant Scheme.

### Environmental initiatives

The Town Council undertakes a number of environmental projects each year. In 2013/14 we:

- Installed a bench at Holmbush
- Improved the flower beds in the town centre
- Facilitated a tree planting scheme at Wheal Eliza
- Liaised with Cornwall Council on improvements to local parks
- Explored the options for the use of surplus land at Acorn Drive.

### **Other initiatives**

The Town Council has:

• Assisted with a new lease for the Community Centre and Arts Theatre and helped fund internal improvement works. • Operated a small grants scheme for local community and charitable groups. The Council gave 23 grants totally £5,630 in 2013/14.

• Begun negotiations with Cornwall Council regarding the devolution of services.

• Undertaken pre-planning consultations with a number of developers, arranged a number of large scale public meetings to give residents the opportunity to raise concerns and suggest improvements to major planning proposals;

• Responded to consultations affecting the town on many issues including Cornwall Council's Local Plan, a Town Framework Plan, cycle ways, road closures, licensing policies and bus shelters.

• Worked closely with local businesses to strengthen their representation and input to local issues;

• Provided funding once again to the St Austell Discovery Map, meaning that the map can be distributed free of charge to members of the public.
